G20 and OECD have been moving very fast in introducing minimum tax on digitalized economy. The relatively low tax rate may no longer be considered as an attraction of Hong Kong. The minimum tax may also render Hong Kong's offshore taxation regime not being meaningful at all. The speaker will explain the mechanic of the minimum tax and how it would impact on the taxation regime of Hong Kong. The speaker will also attempt to make some recommendations to participants in response to the minimum tax.
